RECYCLING CARTS

The Village will be moving toward standardized residential recycling carts beginning late 2017. The cost of the 95 gallon carts is approximately \$60 each and will be a one-time assessment to residential property owners. Outagamie County has negotiated a reduced rate with the supplier that is only available to the Village this year.

The Village chose to participate in the recycling cart program for the following benefits:

- Increased recycling: recycling carts increase recycling tonnage by over 14%;
- Reduced trash tonnage which extends the life of the landfill and lower landfill fees;
- Little/no spill and windblown recycling materials littering streets;
- More competitive rates for recycling pick up with standardized carts and automated process.



Highway 15 Update

The transportation funding plan adopted by the Joint Finance Committee varied from the Governor's budget by REMOVING funding from Highway 15 and INSERTING Highway 23 in Sheboygan County. The Governor proposed a 3 year delay for Highway 23 because the Environmental Impact Statement is not yet complete AND there is pending litigation that is still held up in court.

Highway 15, which has the Environmental Impact Statement complete, has no pending litigation, and has been postponed by budget in 2013 and 2015 has again been REMOVED from the budget.

- ⇒ **Recycling Event:** The total weight recycled at our Aug. 5th event in Hortonville was 7,551 lbs.
- ⇒ **Burning:** All burning (other than campfires) between 7:00 a.m. and 7:00 p.m. Monday thru Sunday.
- ⇒ **Yard Waste Drop-off Site:** The area at 521 W. Cedar Street is for RESIDENTS ONLY. Non-residents will receive a fine.
- ⇒ **Snow Season Parking:** Beginning Nov. 15th, no parking on any street located in the Village between 3:00 a.m. and 6:00 a.m.
- ⇒ **Shoveling:** Property owners must shovel sidewalks within 24 hours of a completed snowfall.

AED Relocated to the New Safety Station Kiosk Downtown

The Village AED (Automatic External Defibrillator) which was most recently located at 208 W. Main Street (Hardtails Salon) has now been moved to its permanent location. The AED has now been moved to the kiosk at the corner of Main Street and Pine Street.

Relocating the AED to the new Safety Station kiosk allows for 24/7 access with a fire extinguisher, first aid kit and security camera.

FREQUENTLY ASKED QUESTIONS

What is being done about Grandview Road? We are applying for a state grant that may cover up to 50% of widening and repaving of Grandview Road. The remaining 50% may be financed through the tax increment generated in Tax Increment District (TID) 3. The village planned the expansion of the TID to include Care Partners and the coming retail center so that the taxes generated could be directed to needed projects such as Grandview Road.

How long are residential building permit fees reduced? The building permit fees will remain reduced until at least December 31, 2020. At that time, the board will reconsider.

Are chickens allowed in the Village? Not at this time. The Public Safety Committee will be considering this in the future because we have received many requests to allow chickens and other poultry.

When will Hortonville have a chief of police? Interviews for the Chief of Police are being held in September. We anticipate that the new police chief will need to give proper notice to his/her current employer, likely starting in Hortonville in November or December of 2017. Sergeant Brian Bahr is designated Officer In Charge until a Chief of Police is in place.

When will Memorial Square be complete? As funding allows. Thanks to generous donations, we have completed the water wall, planter and bench wall, installed the little library, and planted trees and shrubs. The bike rack will be installed soon. We would like to include a drinking fountain and pet watering station combo. We complete components of the projects as we acquire funds.

Why doesn't Hortonville apply for grants for projects? There are very few grants that Hortonville qualifies for. While we are applying for a grant for Grandview Road, many others have maximum resident income limitations or minimum job creation requirements that the Village does not meet. This limits the Village to private foundations and other grants without income or job creation requirements. Many of these require applications to be through a non-profit organization (such as a downtown association) rather than a municipal government.

FALL CURBSIDE PICK-UP

(place at curb by **8:00 a.m.** on dates listed below)

Leaves and raked yard waste must be placed in paper biodegradable bags and must not weigh more than 50 lbs.

Bags will be picked up on:

Mondays: 10/09 10/16 10/23

Tuesdays: 10/10 10/17 10/24

Brush must be 3 inches or less in diameter, cut in lengths of 4 feet or less, and bundled (bundles must not weight more than 50 lbs.). Bundles of brush will be picked up on:

Thursdays: 10/12, 10/19, 10/26

FALL CEMETERY CLEAN-UP

All flower arrangements, real or artificial, must be removed no later than October 15th to allow for a thorough fall cleaning of the cemetery. Persons desiring to reuse such material must claim them prior to that date or they will be discarded by the Village. Christmas, fall and winter arrangements may be placed after November 15th. All Christmas, fall and winter arrangements must be removed no later than March 15th for spring cleaning of the cemetery. The full Union Cemetery rules and regulations can be found on the Village's website or picked up at the Administration Office.
