CURBSIDE YARD WASTE AND BRUSH DISPOSAL

Have materials at the curb by 8:00 a.m.

Residents must use biodegradable bags that can be purchased from area retail stores.

Curbside pickup for leaves and yard waste:

Monday April 13th Monday April 20th Monday April 27th Tuesday April 14th Tuesday April 21st Tuesday April 28th

Curbside pickup for bundled brush:

Bundled brush must be no more than 3 inches in diameter, no greater than 4 feet in length and weigh no more than 50 lbs. in order to be picked up.

NOTE: Garage sales, yard sales and similar merchandise sales may be held no more than twice per year at any residence and for a total of not more than 6 days in that year. The sales shall be conducted between 7:30 a.m. and 9:00 p.m. and last no longer than 4 consecutive days. (Village Ordinance 9.21)

Paying a Bill Online

To make a payment online, go to our website at www.hortonvillewi.org and choose **Online Bill Pay** on the Home screen. Next choose either **Pay Utility Bills** or **Pay Village Bills** and follow the instructions.

Please note that payments tendered through this portal will be assessed a one-time convenience fee based on the total amount due. Convenience fees are in addition to the amount(s) owed and are calculated as follows:

- A 2.20% convenience fee will be charged for payments using Visa, MasterCard, Discover or American Express credit or debit card. The convenience fee is based on the total amount due.
- A fixed \$0.25 convenience fee will be charged for payments using e-check.
- You will have the opportunity to review the total amount due with the convenience fee prior to payment submission.
- While you will be paying fees to the Village of Hortonville, the full amount of the convenience fee is passed to Municipal Services Bureau (MSB) as the provider of this online payment service.



GRASS CUTTING

Per Village Ordinance 10.05, it is the responsibility of the property owner to keep the grass cut the <u>entire grass cutting season</u>.

Failure to keep the grass cut may result in a fine.

GRASS CLIPPINGS

When you are mowing or mulching grass, or blowing or raking up leaves, please keep them out of the street. Grass clippings and leaves flow down the gutter during a rain and eventually plug catch basins. You will receive a fine if you are found to have blown grass or leaves into the street.





In the fall of 2019, the Village of Hortonville was the recipient of two medical assist transport vans from the Outagamie County Aging and Disability Resource Center.

With the support of volunteer drivers, Helping Hands of Hortonville is now an entity of the Village that will help with the transportation needs of Villagers and residents of the surrounding townships.

If you are 55 years or older or disabled and are without means of transportation, we are here to help. You will simply call the Village offices at (920) 779-6011 to reserve your ride appointment.

BUILDING NUMBER/STREET ADDRESS

Are your house or business numbers up to code?

Village building code 14.01(4) states: Each owner must fasten or paint a permanent, legible building number (assigned by the Village) of a conspicuous color contrasting to the building background color, which shall be no less than 3 inches in height on the front face of the building abutting the street.

If the building is set back forty (40) feet or more from the front property line, the property owner may place and maintain the required number on a mailbox or sign post located at or near the property line.

Please be reminded that clusters of mailboxes with numbers on them do not properly distinguish residences for emergency responses, and could result in delayed response times.

Violating this ordinance is punishable by an ordinance citation. Police, fire, first responders and ambulance services need your cooperation to expedite services. Thank you.

Another season of weed harvesting will soon be here. Last summer, Janet, Todd and I were able to harvest over 500 cubic yards of weeds. Having acquired our own truck, this year we might be able to harvest more (weather permitting). The harvester has been taken to Evergreen Equipment LLC for maintenance where Delvon Weaver is doing some warranty work on it. Hopefully it will be returned and ready to go in May.

DASH (driver assisted succession harvesting) will be back again this year. They are having discussions with Lake and Pond Solutions to determine the best area/s to be harvested.

Notice to residents with lake shore property. The Black Otter Lake District will not be responsible for any damage done to docks that are left in the water over the winter.



Briggs Street Utility Project

Aging utility infrastructure along the 200 block of Briggs Street will be removed and replaced. This project also includes the complete surface restoration of Briggs Street, from W. Main Street to W. Cedar Street.

<u>Birch Street Resurfacing Project – 300 Block</u>

This localized paving project will include milling and resurfacing the roadway along the 300 block of Birch Street, from Nye Street to Hickory Street.

Lincoln Street Pavement Patching & Repair

Sections of roadway along the 600 block of Lincoln Street will be pulverized and repaved due to excessive utility trench settling.

During construction projects, it may be necessary to partially or completely close streets to vehicular traffic due to safety concerns. Street parking may be temporarily restricted along the affected streets.

HORTONVILLE UNION CEMETERY

Spring Cleanup

In order to facilitate cleanup of Union Cemetery, all flower arrangements, real or artificial, needed to be removed from gravesites no later than March 15, 2020. Any unsightly or damaged items that are not removed in a timely manner will be so removed at the discretion of the Village of Hortonville. During this spring cleanup period, an individual who has an anniversary of the death of their loved one may place a floral arrangement, decoration, etc. in their memory next to the headstone or in the trim and stone enclosure. Spring and summer arrangements may be placed after April 15th of each year.

Anyone interested in getting a complete copy of the Rules, Regulations and Policies for the Union Cemetery should come to the Village's Administration Office and pick up a copy. It is also recommended that you check the Village's website, www.hortonvillewi.org, to read these Rules, Regulations and Policies.



Remember that according to Village Ordinance 9.04 all burning (other than campfires) shall be conducted only between the hours of 7 a.m. and 7 p.m. Monday through Sunday. Controlled burning of dry leaves and other non-offensive dry yard debris, and small campfires should be located at least 30 feet from any neighboring structure. Burning brush piles or controlled burning of grass or similar vegetation for environmental management purposes requires written approval from the Fire Chief.



2020 DOG LICENSES

All dogs kept in the Village needed to be licensed by the end of the day on Tuesday, March 31, 2020. You must purchase a dog license every year. The 2020 license is valid 1/01/2020 through 12/31/2020.

PETS IN THE VILLAGE

There are current ordinances that address the issue of pet owners keeping their animals restrained. The goal is to prevent problems such as an unrestrained, running at large pet becoming a public nuisance to other residents.

Pets running loose can be impounded and their owner will be responsible for payment of an appropriate fee that is imposed at the time the animal is reclaimed.

Dogs are not allowed anywhere in Otto Miller Park; there is a sign posted. Dogs are allowed in other Village parks but must be restrained.



POOL FILLING CREDIT

Upon request by water and sewer utility customers, a seasonal sewer credit based on the number of gallons above two thousand (2,000) gallons will be issued for a residential customer swimming pool. The customer must notify the utility of the number of gallons the pool holds or a before and after meter reading to receive the seasonal credit.



May 12-14, 2020 September 15-17, 2020

Hydrants are flushed twice a year in order to provide our customers with the best water quality possible.

Tuesday: All areas NORTH of Main Street, State Highway 15, to the Village limits.
Wednesday: All areas SOUTH of Main Street, State Highway 15, to the Village limits.
Thursday: All areas that may be incomplete from the previous days.

If you notice employees flushing in your area, **do not run water until they have left the area**. If you notice discolored cold water in your home, do not run any <u>hot water</u> until your cold water is clear. If you notice discolored hot water, you should flush your water heater. There is a connection for a garden hose on the bottom of most water heaters to clean any build up from the hot water tank.

Flushing ensures proper operation of hydrants and also removes loose scale accumulation from inside the water mains. Slightly discolored water may appear in your home. This does not mean your water is unsafe to drink. If discolored water continues to be a problem, please call Superintendent OIC Ryan St. John at 779-4086.

COMPOST SITE

Residents are invited to drop off their yard waste and brush at the compost site located by the Wastewater Treatment Facility, 521 W. Cedar Street. Be prepared to show an I.D. or utility bill.

It is illegal for **NON-VILLAGE RESIDENTS** to leave or discard any article or items (including yard waste), or allow any article or item under his or her control, to be deposited at the Village of Hortonville's yard waste drop-off site. If any NON-VILLAGE RESIDENT is caught depositing anything at the Village of Hortonville yard waste site, they will receive a fine and/or summons. The Village of Hortonville may dispose of the waste or waste material itself at the expense of that person found illegally disposing the waste.

PENALTY. Any person who shall violate the above provision shall be subject to a penalty as provided in Sec. 9.17 of the Hortonville Municipal Code.

SUMP PUMP DISCHARGES

No property owner, renter, lessee or leasor in the Village shall place the end of their sump pump discharge hose or pipe closer than ten feet (10') from the outside edge of the established curb. In the absence of a curb, the end of the discharge apparatus shall not be closer than ten feet (10') from the roadway.

The distance shall be measured in a straight line, regardless of hose or pipe angle, from the end where the water is discharged to the outside edge of the curb or the closest edge of the roadway.

No sump pump discharge shall be directed so as to drain onto a driveway or other device to which the water would drain onto the Village street.

The connection of any private sump pump discharge to the Village's sanitary sewer system is not allowed.

Any property owner, renter, lessee or leasor found to be in violation of Sections 8.09(3) or (4) shall have seventy-two (72) hours from the time of notice to correct said problem or be subject to a fine as set by the governing Board of Village Trustees.
