- 5. Vehicles, equipment and materials shall be so regulated by the Permittee as to assure consistently safe conditions. Particular care shall be exercised at all times to assure a safe traffic environment at and near the site of the work. These requirements pertain while the work operations are in active progress, as well as during periods of work shut-down. Any discovered violation will result in an order by Village authorities to stop any and all further progress of the work and may result in revocation of the Permit.
- 6. The entire cost of installing and maintaining the facility in the Village right-ofway shall be the responsibility of the Permittee.
- 7. Any drawings/specifications contained or otherwise referenced herein shall control the Permittee's work, which shall be completed as shown therein. Failure to complete the work as detailed or as otherwise required herein shall allow the Village to thereafter complete the work and charge the Permittee the full cost of correction/completion.
- 8. A field inspection by an authorized Village representative shall be required prior to completion.
- 9. Any dirt or debris resulting from the installation and/or maintenance of said facility in the street/road right-of-way shall be removed as soon as possible by the Permittee.
- 10. Any turfed area of the right-of-way disturbed by the permitted work and operations shall be restored with fine-graded topsoil having a depth of not less than four (4) inches and shall be reseeded with perennial grass or sodded.
- 11. Any erosion control plans as may be required shall be the sole responsibility of the Permittee.
- 12. When the work is completed, the street/road shall be fully restored to its former condition. In case the Permittee hereunder or any contractor fails to restore the area to such original condition, the Village shall have the right to complete the work in whatever manner it feels proper and the Permittee and its contractors shall be liable for damages for whatever amount of expense necessary to complete the job.
- 13. The Permittee shall be financially responsible for all damages caused by the Permittee's contractors or other agents.
- 14. This Permit authorizes only the described work of and for the Permittee indicated earlier. It does not authorize work for the facility of any other, either by present or future installation.
- 15. Construction method and restorations shall be in accordance with applicable parts of the Wisconsin Department of Transportation Standard Specifications for Road and Bridge Construction, current edition.
- 16. Permitted facilities shall be located as defined within this Permit. Any part of the facility found to be otherwise located shall be subject to correction by and at the cost of the Permittee to such extent as the Village Department of Public Works may specify. Any facility or part thereof which is located other than as the Permit defines occupies such location solely at the risk of the Permittee.
- 17. The Permittee and its agents shall comply with all ordinances, statutes and regulations which may apply to Permittee's work.
- 18. By executing this Permit, if it is granted, the Permittee agrees that it must comply with all of the foregoing conditions as an integral part of its agreement with the Village of Hortonville. Furthermore, the undersigned states that they have the authority to sign on behalf of the Permittee.
